The number of vacancies in each category may increase or decrease. Vertical reservation for S.C., S.T. and O.B.C. of U.P. and Horizontal reservation as per rules shall be applicable. Maximum age limit shall in the case of candidates of the S.C., S.T. & other categories candidates of U.P. be enhanced as per applicable rules.

Fee for General (Unreserved) and OBC category candidates for each post shall be Rs.800/- (bank charges extra) and the fee for SC/ST category of Uttar Pradesh for each post shall be Rs. 600/- (bank charges extra). The candidates belonging to the Horizontal category shall have to pay fees according to their original category.
