In case a candidate is making correction of his/her category/sub-category from lower fee to higher fee prescribed, he/she shall have to make payment of additional/differential fee through Debit Card/Credit Card/Net Banking during the online correction period. However, no refund or adjustment would be made against the change of category/sub-category having from higher to lower fee prescribed.
