### Procedure for Challenge of Answer Key

3. Login with your **Application Number and Date of Birth** and enter **Security Pin** as displayed and **Submit**.
4. Click 'Apply for Answer Key Challenge(s)'.  
5. You will see 100 Questions in sequential order.
6. The number next to the Question under the column '**Correct Option/Answers**' stands for the correct /most appropriate Answer Key to be used for compilation of result.
7. If you wish to challenge this option, you may use anyone or more of the Options given in the nest four columns by clicking the checkbox
8. You may upload supporting documents in which you can select 'Choose File and upload' (**all documents to be put in a single pdf file only**).
9. After clicking your desired option, '**Save your Claim**' and move to the next screen.
10. You will see a screen displaying your **challenges**.
11. Click on '**Save your Claim and Pay Fee Finally**'.
12. Select Mode of Payment and Pay a processing fee @ ₹ 500/- for each question challenged.
13. After successful payment, download/print the Answer Key Challenge receipt.
