In case a candidate is making correction of his / her category / sub-category from lower fee to higher fee prescribed, he / she shall have to make payment of additional / differential fee through Debit Card/Credit Card/ Net Banking during the online correction period. However, no refund or adjustment would be made against the change of category / sub-category having from higher to lower fee prescribed.
