Fee for General (Unreserved) and OBC category candidates for each post shall be Rs.800/- (bank charges extra) and the fee for SC/ST category of Uttar Pradesh for each post shall be Rs. 600/- (bank charges extra). The candidates belonging to the Horizontal category shall have to pay fees according to their original category.

The Objective Type Test and Computer Knowledge Test shall be conducted in **Computer Based Test Module** (**CBT Module**). The information regarding Date, Time and Venue of the Examination/Tests shall be intimated to the candidates through online admit cards only.
