

**Corrigendum to Empl. Advt. DU No. Estab.IV/290/2021  
Dated: 23.02.2021**

**Recruitment to Non-Teaching Posts in DU**

Following corrigendum is issued with respect to the Information Brochure & Guidelines for filling of online application form for recruitment of non-teaching positions in Delhi University for information of all concerned:

1. **Pay Level as per VII CPC mentioned** as 'Level 03' against 'Post Code P0301' at **Sr. No. 43 on Page No. 8 be read** as 'Level 4'.

2. **Section-E Sr. No. 2(c) under 'AGE RELAXATION' on Page No. 78** stated below:

The upper age-limit as prescribed for direct recruits shall not be insisted upon in the case of departmental candidates of the University/college(s).

The upper age limit will also be relaxed to the extent of service rendered by them in respect of persons who are already working on contract/daily wages/ad-hoc basis in the University or its College(s) provided they have put in atleast one year of service. (The relaxation will be subject to other applicable rules and also production of relevant experience certificate from the University or the concerned College where the applicant has served).

**Be read as :**

The upper age-limit as prescribed for direct recruits shall not be insisted upon in the case of departmental candidates of the University/college(s) working against substantive posts on regular basis.

Further, one time exemption in the upper age limit in respect of persons who are already working on contract/daily wages/adhoc basis in the University or its College(s) provided they have put in atleast one year of service is extended to all such persons irrespective of their age at the time of joining the University in respective category. (The relaxation will be subject to other applicable rules and also production of relevant experience certificate from the University or the concerned College where the applicant has served).

Note: This exemption is extended only to the contract/daily wages/adhoc employees appointed directly by the University or its affiliated / constituent Colleges. It shall not be applicable to the employees working on contract basis in project based assignments or through outsourced agencies in the University or its Colleges.

3. **Section-E Sr. No. 2(e) under 'AGE RELAXATION', entries at S. No 6 and 9 on Page 78 & 79** stated below:

| 6.    | Ex-Servicemen and commissioned Officers including ECO/SSCOs   | 5 years  |
| 9.    | Persons who are already working on contract/daily wages/ad-hoc basis in the University of Delhi or its College(s) | upper age limit will be relaxed to the extent of service rendered by them in the University of Delhi or its colleges |
